

# **BOARD OF DIRECTORS AND ANNUAL MEETING**

**Summary of Major Actions and Discussion** 

(These are not official minutes of the CHEA Board of Directors.)

Chair Orlando Taylor called the meeting to order at 3:00 p.m.

### TREASURER'S REPORT

The board of directors:

- Received the FY20 third quarter financial report.
- Received an update on FY20 institutional membership.

## AD HOC SEARCH AND TRANSITION COMMITTEE

The board of directors approved the estimated budget to fund the *Ad Hoc* Search and Transition Committee. Funds from the Directors Book Fund will be used to finance the search for a new CHEA president.

## **GOVERNMENT AFFAIRS REPORT**

Vice President for Government Relations Jan Friis reported that Covid-19 pandemic has dominated agendas in Washington. CHEA has worked with other higher education associations to advocate for Covid-19 assistance for students and institutions with community letters to Congress and several federal agencies. He also reported that there is a likelihood of another Covid-19 relief bill at the end of May or the beginning of June. The U.S. Department of Education (USDE) has issued waivers for institutions and accrediting organizations in meeting the challenge of Covid-19 concerning distance education and accreditation visits. USDE is considering extending the waivers, perhaps semester by semester.

## PRESIDENT'S UPDATE

At the Working Session, President Eaton reported on CHEA's efforts to maintain service to its member institutions and accrediting organizations during the pandemic. Staff have been working remotely since the last week in March 2020. All major CHEA functions, government affairs, recognition, membership services and international quality assurance, are being maintained. CHEA has hosted a number of webinars for its institutional members and the public as well as webinars with the accrediting community. Other CHEA events, e.g., the May 2020 board of directors meeting and the June 2020 committee on recognition meeting, are being held virtually, as will the 2020 Summer Roundtable scheduled for late June 2020. CHEA has continued regular issues of Accreditation in the News, International Quality Assurance in the News, the Federal Update, the Quality International newsletter and Inside Accreditation. The webinars for the public are being recorded and posted on the CHEA Website and an accreditation-Covid-19 resource page has been established as well.
