Summary of Major Actions and Discussion

(These are not official minutes of the CHEA Board of Directors.)

Chair Gena Glickman called the meeting to order at 1:00 p.m.

Treasurer's Report

The board of directors:

- Received the FY23 third quarter financial report.
- Received an update on FY23 institutional membership.

Working Session

During the Working Session the board received a Task Team update, approved an update to the Bylaws, approved the use of board designated reserves for CHEA's marketing initiatives. They also received a final report on the 2023 Annual Conference and a CIQG membership update.

Government Affairs Report

Senior Vice President for Government Relations Jan Friis reported on the meetings held with committee staff for the U.S. House of Representatives and U.S. Senate Education Committee Democrats and Republicans. Short-term Pell legislation, with an impact on accreditation, is the current issue for the committees. He reported that CHEA briefed the incoming staff on accreditation and its importance.

Friis reported on the intent for the Department of Education (USDE) to hold negotiated rulemaking on a series of topics including accreditation, state authorization, distance education and a range of other topics. USDE held its public hearing April 11-12, and a number of topics were raised to be included in the accreditation rulemaking.
